## GENERAL AGREEMENT ON ESTABLISHING THE JOINT NETWORK “Silistra - Calarasi European Destination”

### I. Introduction

In recognition of the well-established cooperation between the signed parties from the region Silistra, Bulgaria and Calarasi, Romania, this General Agreement marks their commitment to further upgrade and develop their networking.

### II. Intention of the agreement

The document takes into account our mutual interest in alternative tourism development as part of the regional prosperity as well as in nature preservation for the next generations.

Thus the current agreement governs the mutual relations and joint efforts of the signed parties to promote the image of the region Silistra, Bulgaria and Calarasi, Romania and contribute to its sustainable development

### III. Focus areas of the agreement

To achieve that all parties signed below declare that:

- 1) **They set up a Joint Network ‘Silistra - Calarasi European Destination’** as a result of the implementation of the project One Cross-Border Region-One European Destination, financed by the CBC RO-BG 2007-2013 Programme;
- 2) **The network unites representatives of all regional stakeholders:** authorities, companies and organizations, providing tourist services, journalists, NGOs and persons and welcomes any other party, which is ready to contribute to the economic development of the cross-border region Silistra - Calarasi;
- 3) They agree to participate in all joint activities, targeted at designing and implementing joint cross-border policies for **alternative tourism development**;
- 4) They also declare that they will follow the **European horizontal policies** when planning and elaborating business activities so that the regional habitat and the Danube waters remain unpolluted and preserved;
- 5) They agree to have their **organizational profile publicised on the website [www.cbctourist.eu](http://www.cbctourist.eu)** as well as to provide other professional tourist-oriented information upon request.

### IV. Administration

Each party shall designate one representative, responsible for the network functioning.

These representatives shall administer the general practical aspects of the cooperation, coordinate project information, and offer professional assistance if necessary.
